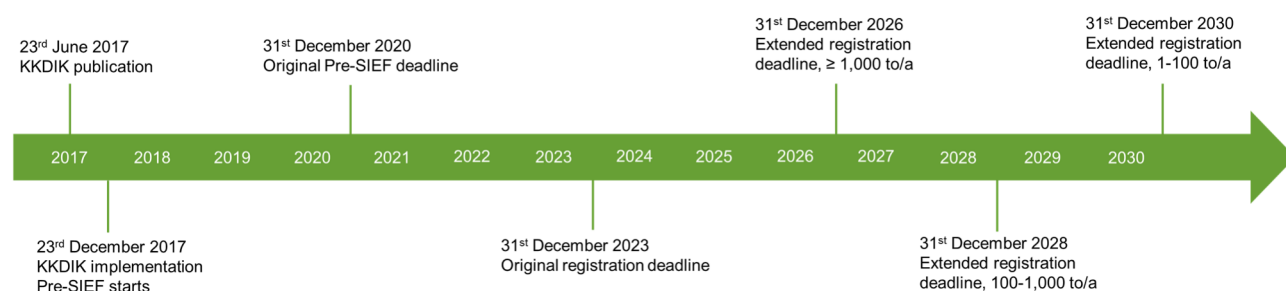
KKDIK | Turkish REACH

Several products within the Dr. Paul Lohmann® product range are concerned by the various REACH legislations, including the metal salts synergized under the Lohtragon® brand. REACH stands for the Registration, Evaluation, Authorization and Restriction of Chemicals. The main objective of the chemicals legislation is to ensure a high level of human health and environment protection.

Initially REACH is a regulation of the European Union (EU REACH), which has been followed by further country legislations, such as South Korea (K REACH), Great Britain (UK REACH), and Turkey (Turkish REACH | KKDIK).

KKDIK is the Turkish REACH regulation for products that are produced in or imported to Turkey, covering the Turkish Ministry of Environment, Urbanization and Climate Change (MoEUCC) regulation on chemicals and their safe use. It was published on June 23rd, 2017, with an initial KKDIK registration deadline of December 31st, 2023. On December 23rd, 2023, this deadline has been revised by the MoEUCC based on a “Tonnage Based Gradual Transition” approach, and is extended as follows:

- ◆ **31.12.2026:** Amount of $\geq 1,000$ tons/year is manufactured or imported as such or in mixtures or articles*
- ◆ **31.12.2028:** Amount of ≥ 100 tons/year is manufactured or imported as such or in mixtures or articles
- ◆ **31.12.2030:** Amount of ≥ 1 ton/year is manufactured or imported as such or in mixtures or articles



Dr. Paul Lohmann® has successfully appointed YORDAS GmbH as its Only Representative (OR) for KKDIK requirements – please find the OR appointment on the following pages – and has done several pre-registrations.

These pre-registrations remain valid also under the revised deadlines. Thus, we can continue to import our pre-registered products to Turkey in quantities ≥ 1 to/a also after January 1st, 2024, up to the new deadlines. Moreover, the extended KKDIK registration deadlines do not affect already submitted registrations.

In case of any KKDIK requirements please communicate your concerned products and expected volumes, so that we can check the individual (pre-)registration status and general KKDIK frame, in order to consider the concerned substances for KKDIK registrations. We look forward to it – our REACH department provides full service for you.

*The extended registration deadline for December 31st, 2026 differentiates also the hazards status of substances. As this status does not apply for any Dr. Paul Lohmann® product, these cases are no further considered on this info sheet.
