UA REACH | Ukraine REACH

Several products within the Dr. Paul Lohmann® product range are affected by the various REACH legislations, including the metal salts marketed under the Lohtragon® brand. REACH stands for the Registration, Evaluation, Authorization and Restriction of Chemicals. The main objective of the chemicals legislation is to ensure a high level of human health and environment protection.

Initially REACH is a regulation of the European Union (EU REACH), which has been followed by further country legislations, such as South Korea (K REACH), Great Britain (UK REACH), and Turkey (Turkish REACH | KKDİK).

With its approval on July 23, 2024, it is now evident that the next REACH regulation is coming up: the Technical Regulation for the Safety of Chemical Products, commonly referred to as **Ukraine REACH (UA REACH)**. It refers to substances that are produced in or imported to the Ukraine and is regulated by the Ministry of Economy, Environment and Agriculture of Ukraine (MEEA).

Under Ukraine's forthcoming chemical UA REACH regulation, a **pre-registration phase** is scheduled to commence on **January 26, 2025**, lasting until **January 26, 2027**. This period allows to pre-register existing chemical substances, facilitating their continued Ukrainian market presence during the transition to full registration.

Following the pre-registration, the **registration deadlines** are structured based on the "Tonnage Based Gradual Transition" approach and specific hazardous properties of the substances:

- ◆ 01.10.2029: Amount of $\geq 1,000$ tons/year is manufactured or imported as such or in mixtures or articles*
- ◆ 01.06.2031: Amount of ≥ 100 tons/year is manufactured or imported as such or in mixtures or articles
- ◆ 01.03.2033: Amount of ≥ 1 ton/year is manufactured or imported as such or in mixtures or articles



For any UA REACH requirements, please provide details about the relevant products and expected volumes. This will allow us to verify their (pre-)registration status and to assess the overall UA REACH framework to ensure the substances are considered for registration.
